OCTOBER 9TH - 5:00PM
Deadline to register to vote

OCTOBER 10TH
Early voting begins and ballots mailed

OCTOBER 26TH - 5:00PM
Last day to request an early ballot by mail

NOVEMBER 1ST
If you plan to mail your ballot, do it no later than this day

NOVEMBER 2ND - 5:00PM
Last day to vote early in person

NOVEMBER 6TH
Election Day - 6:00am to 7:00pm
